In the beginning of a new school year, there are many important issues. Please be informed of the following:

1. Lunch period

In accordance with the school rules, all students are required to stay at school for lunch.

2. Concerns for Physical Education lesson

(i) Participation in Physical Education

As Physical Education is part of the Key Learning Area of the school curriculum, students are required to take part in Physical Education lessons. Students who cannot do so are required to provide the school with a medical certificate from a registered medical practitioner.

Please complete the Reply Slip of “Concerns for Physical Education lesson” on or before 04/09/2019 (Wednesday) so that special arrangement can be made. Any changes in students’ health must be reported to the school immediately.

(ii) Requirement of Physical Education uniform

Students are required to wear the designated Physical Education uniform (Refer to Pages 11 to 14 of the student handbook). For standardization, students must follow the school rules. Any violation of the rules for five times in a term will be subject to disciplinary action.

3. Collection of medical history of student

(i) Purpose of collection

As suggested by the Education Bureau, our school has to keep a record of student medical history so that we can provide appropriate assistance if needed. It is important for parents to provide the school with sufficient information about their child’s medical history to class teacher at the back of student information form on or before 04/09/2019 (Wednesday) so as to prevent any unnecessary accidents from happening in Physical Education lessons or other extra-curricular activities.

Personal data collected from your child is only used for handling matters related to his/her health and safety. Though the provision of such data is done entirely on a voluntary basis, insufficient information may prevent the school from fully understanding your child’s medical history. The school may not be able to provide proper assistance to him/her in case of an accident.

(ii) Access to personal data

According to the Personal Data (Privacy) Ordinance, parent/guardian has the right to access and correct the data provided. Please contact the school if needed.



4. Permission of the use of creative work, photos and video clips taken during students participation in learning activities

Our school is now working with the Education Bureau, educational institutions and various government departments to conduct different research studies in learning and teaching. In the collaborative process, our school have made a compilation of your child's learning and work. To share a range of excellent exemplars of learning and teaching with fellow colleagues in the education community and to affirm the concerted effort made by teachers and students in the learning process, our school will disseminate selected exemplars on the website, in the Education Bureau publications, in newspapers and magazines, in teacher networking activities, exhibitions, and teacher sharing sessions to offer support among fellow colleagues and promote related research in learning and teaching.

We hereby ask for your consent to let us use the photos, video clips and work with your child's participation. Please complete the reply slip so that special arrangement can be made.

5. School bus service

To enable students to have sufficient time for morning reading and school activities, the school will provide school bus service in the morning. Details are as follows:

Successful applicants are required to settle the bus fee via e-payment on 13/09/2019 (Friday).

Note: Students who have already completed the application process during the summer holiday, the school bus service will be commenced on 02/09/2019 (Monday).
