# Special Notice No.5 (2020/2021) (S.1~S.4) "Bring Your Own Device (BYOD)" E-Learning Programme: Purchasing Mobile Computer Devices

19th October, 2020

Dear parents/guardians,

To develop students' IT competency, our school has sent an e-notice to parents in August to investigate parents' preference about the Community Care Fund Assistance Programme – Provision of Subsidy to Needy Primary and Secondary Students for Purchasing Mobile Computer Devices to facilitate the practice of E-Learning. The result revealed that some parents are willing to purchase a tablet through the school's bulk order. The school has completed the tendering process. The Incorporated Management Committee has approved the decision that the school can represent the parents to purchase mobile computer devices, which are below the market prices, for students. The following are details of the packages:

# Notes for Recipients of CSSA, Full Grant and Half Grant of the School Textbook Assistance Scheme:

- 1. Students participating in the Community Care Fund Assistance Program must be receiving CSSA, full grant and half grant of the School Textbook Assistance Scheme in the 2020/2021 school year.
- 2. Each student who receives assistance from the Community Care Fund can only receive funding once during the three-year implementation period (2018/2019 to 2020/2021 school years) to purchase a mobile computer device and related accessories. If the aided student has purchased a mobile computer device under this assistance program in another school, the student concerned must return the original device and accessories (if applicable) to the original school to be eligible to apply for the assistance program at this school.
- 3. If it is found that the parents/guardians who have applied for the Community Care Fund Assistance Program to purchase a mobile computer device but have not returned the mobile computer device to the original school at the same time, the difference between the mobile computer device and accessories (full amount of \$4,518 / half amount of \$2,259) must be paid to the school.
- 4. Parents/guardians who intend to apply for the Community Care Fund Assistance Program must submit the following documents to the school:
  - i) Signed Reply Slip
  - ii) Parent/Guardian Consent Form of the Application of the Community Care Fund Assistance Programme Provision of Subsidy to Needy Primary and Secondary Students for Purchasing Mobile Computer Devices to Facilitate the Practice of E-Learning (2020/2021 school year)
  - iii) A copy of the documentary proof of eligibility [the "Certificate of Comprehensive Social Security Assistance Recipients (for Medical Waivers)" or Full Grant/Half Grant of School Textbook Assistance Scheme from the Student Finance Office]

#### **Payment Methods:**

If you would like to purchase a tablet package through the school's bulk order, please prepare a crossed cheque (payable to PCCW) and give it to the class teacher on or before 21/10/2020 (Wednesday).

The service provider will arrive at school on 30/10/2020 (Friday) from 9 am to 12 noon. Payment can be made by any of these three ways in person on that day: cash, crossed cheque (payable to PCCW), credit card (6-month interest-free installment for payment more than \$1500, and 12-month interest-free installment for payment more than \$4000).
