Dear Parent/Guardian,

Please be informed of the following:

1. Application of Student Grant

To alleviate parents' financial burden in defraying education expenses, a one-off student grant of \$2,500 will be provided regularly starting from the 2020/2021 school year for each secondary day-school student by the Government. The student grant will be non-means-tested. All students, except holders of student visas for entry into Hong Kong for studies and holders of Recognizance Forms issued by the Immigration Department, are eligible for the grant. Application forms have been distributed today. Parents/Guardians should submit the completed and signed application forms to **class teachers on or before 15/10/2021 (Friday)**. The school will return the completed application forms in batches to the Education Bureau. The subsidy will be disbursed via bank transfer into the local bank accounts which are provided on the completed application forms. The EDB will contact parents via SMS and email as appropriate to inform them of the status of their applications.

2. Note on how to complete the application form

(A) Form B (Pre-printed with basic information of the student as well as that of the applicant):

Parents/guardians are only required to:

- (i) check if all pre-printed information is correct,
- (ii) choose the language of SMS notifications,
- (iii) put a“√” in the confirmation box at the bottom part of the form and
- (iv) sign to confirm.

If some of the pre-printed information on Form B **requires updating (information other than Student's Name in English, Name of Day-school and School Type)**, parents/guardians have to **provide the amendment(s) in the space above the relevant information in BLOCK letters using black or blue ball pen [correction fluid or tapes should not be used for making amendment(s)], and leave the confirmation box at the bottom part of the form blank.**
